CONSTITUTION OF INDIA.

No. SCT. 6572/3003(207)/TE-2(B).—In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all existing rules, orders or instruments made in this behalf, the Governor of Maharashtra is hereby pleased to make the following rules regulating recruitment to the post of Inspector of Technical Education redesignated as Inspector of Vocational Education and Training in the Maharashtra Educational Service, Class-I (Junior), namely :-

- 1. (i) These rules may be called the Inspector of Technical Education redesignated as Inspector of Vocasional Educational and Training in the Maharashtra Educational Service, Class-1 (Junior), (Recruitment) Rules,
- (ii) These rules shall be deemed to have come into force with effect from the 11th day of February, 1977.
 - 2. In these cules, unless the context requires otherwise,
 - (a) "Cemmission" means the Maharashtra Public Service Commission
 - (b) "Degree" means a degree of a statutory University
 - (c) "Diploma" means a deplome awarded by the Board of Technical Lyamimations. Moharashira Saust, or by the Institution recognised by the Government or its equivalent
 - (a) 'Government' means the Government of Maharishira
- 3. Appointment to the post of Inspector of Technical Education redesignated as Inspector of Vocation | Education and Training in the Maliarashtra Educational Service, Class-I (Junior), shall be made either.
 - (a) by promotion of a suitable person on the basis of seniority subject to fitness from amongst the persons holding post from the cadre of Maharashtra Educational Service, Class-II, having not less than three years con inuous service in that Cadro in the Mechanical or Electrical Engineering Groups and possessing the qualifications and experience prescribed for appointment by nomination in clause (b); or
 - (b) by nomination from amongst candidates who,-
 - (i) unless already in the service of the Government are not more than thirty five years of age;
 - (ii) possess a Bachelor's degree in Mechanical or Electrical Engineering or in both at least in Second Class or a Master's degree in Mechanical or Electrical Engineering or in both; or
 - (iii) possess a diploma in Mechanical or Electrical Engineering or in both at least in second class and have passed sections A and B of the Associate Membership Examination of the Institution of Engineers (India); and

(iv) have professional experience in a responsible position or experience of teaching the subject in any recognised Technical Institute or combined Professional, teaching and research experience, for not less than three year; gained after acquiring the basic academic qualification mentioned in sub-clause (ii) or (iii); or

(v) possess a diploma in Mechanical or Flectrical (inplue ring or in both at least in Second Class with Seven years' experience as meetioned in sub-clause (ir):

Provided that,

(i) in the case of candidates having Master's degree the period of not more than two years, spent in acquiring the degree, and in the case of whose who have completed a course of the Technical Teachers' Training under a scheme of the Government or of the Government of India, the period spent in completing the sense, in no cas; exceeding two years, shall be counted town as the prescribed period of experience;

(ii) any requirements in respect of the qualifications may be relaxed in favour of candidates who have done original research work of outstanding merit:

(iii) if the candidates having experience for prescribed period are not available in sufficient number, then those having experience of a shorter period may also be considered;

(iv) the age limit may be relaxed by Governmen on the recommendation of the Commission in favour of andidates having exceptional qualifications or experience or both

(v) preference may be given to candidate who.--

(a) possess a Master's degree in Engineering; on

(b) have research experience; or

(c) have teaching experience under the Craftsman Training Scheme; or

(d) are members of a professional Institute.

- 4. Notwithstanding anything contained in sub-clauses (ii). (iii), (iv) and (v) of clause (b) of rule (3), if at any stage of selection, the Commission is of the opinion that sufficient number of candidates possessing the requisite higher basic academic qualification or experience are not available to fill up the vacancies reserved for candidates belong to the Scheduled Castes, Schedule Castes converts to Buddhism, Scheduled Tribes, Denotified Tribes or Nomadic Tribes, then the Commission may, in the case of such selection, relax the requirement in respect of the class in the degree or diploma or the period of experience or both set out therein, and select suitable candidates belonging to such Castes or Tribes.
- 5. Appointments to the posts by promotion and by nomination shall be made in the ratio of 50:50.
- 6. A person appointed to the post by nomination shall be on probation for a period of two years.

A person appointed to the posts, whether by promotion or by comination shall be required to pass the Departmental Examinations and examinations in Hindi and Marathi according to the rules made in that behalf unless he has already passed or has been exempted from passing behalf, unless be has alread passed, or has been exempted from passing those examinations.

8. A person appointed to the post shall be liable for transfer anywhere in the State of Maharashtra.

9. Notwithstanding anything contained in rule 5, if in the opinion of the Government the exigencies of service so require, Government may after consultation with the Commission, wherever necessary, make appointments to the posts of Inspector of Technical Education redesignated as Inspector of Vocational Education and Training in relaxation of the percentage prescribed in these rules for recruitment by nomination.
