CONSTITUTION OF INDIA.

No. RTR. 1186/CR-110/86/SER-I.- In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Maharashtra is hereby pleased to make the following rules regulating recruitment to the post of Library Assistant, Class-III in the Directorate of Health Services under the Public Health Department of the Government of Maharashtra, namely: -

These rules may be called the Library Assistant in the Directorate of Health Services under the Public Health Department (Recruitment) Rules, 1990.

2. In these rules, unless the context requires otherwise 'Government' means the Government of Maharashva.

3. Appointment to the post of Library Assistant in the Directorate of Health Services shall be made by nomination from amongst candidates who.-

(a) unless already in the Service of Government are not more than twenty-eight years of age;

(b) possess a degree in science of a statutory University preferably

with the subject of Biology and Zoology;

(c) possess a diploma of an institution recognised by Government (d) have an experience for a minimum period of six months gained after acquiring the qualification mentioned in clauses (b) and (c):

Provided that, the age limit may be relaxed by Government on recommendation of the appointing Authority in favour of candidates having exceptional qualifications or experience or both.

4. A person appointed to the post shall be on probation for a period of one year.

A person appointed to the post shall be required to pass examinations in Hindi and Marathi according to the rules made in that behalf, unless he has already passed, or has been exempted from passing these examinations.

- 1. These rules may be called the Deputy Apprenticeship Advisor (Senior), and Deputy Director of Vocational Education and Training-cum-Deputy Apprenticeship Advisor (Senior) in the Directorate of Vocational Education and Training (Recruitment) (Amendment) Rules, 1989, namely :-
- 2. In the Deputy Apprenticeship Advisor (senior) and Deputy Director of Vocational Education and Training-cum-Deputy Apprenticeship Advisor (senior) in the Directorate of Vocational Education and Training (Recruitment) Rules, 1986 (hereinafter referred to as "the principal rules"), in the preamble, in sub-rule (i) of rule 1 and in rules 3 and 9, for the brackets and word '(Senior)' wherever they occur, the brackets and word '(Senior)
- 3. In sub-rules (i) and (ii) of rule 1 of the principal rules, for the brackets and figures "(1)" and "(ii)", the brackets and figures "(1)" and "(2)" shall, respectively, be substituted.
- 4. In rule 2 of the principal rules, in clause (c), the word "thereto" shall be deleted.
 - 5. In rule 3 of the principal rules, in clause (B),—
 - (1) for sub-clause (ii)(c), the following shall be substituted; namely
 - "(c) professional experience in an Engineering or Technology concern preferably engaged in production or experience of teaching in an Engineering College or Polytechnic or Technological Institute or combined professional and teaching experience of the abovementioned type, for not less than five years; gained after acquiring the qualification mentioned in sub-clause (ii)(a) or (ii)(b) above."
- (2) in sub-clause (ii)(d)(ii), for the portion beginning with the words "professional or teaching experience" and ending with the words "equivalent or higher post" the following shall be substituted, namely:—
- "teaching or professional and teaching experience of the type mentioned in sub-clause (ii)(c) above, for not less than ten years, out of which at least five years should have been in the capacity of Principal, Industrial Training Institute or an equivalent or higher post, gained after acquiring the qualification mentioned in sub-clause (d)(i) above ".
