And whereas, the Government of Maharashtra has reason to believe that the Shri Parayi Kozhiparambath Abdulla in respect of whom the said detention order has been made has absconded or is concealing himself so that the said detention order cannot be executed;

Now, therefore, in exercise of the powers conferred by clause (b) of sub-section (1) of section 7 of the said Act, the Government of Maharashtra hereby directs the said Shri Parayi Kozhiparambath Abdulla to appear before the Commissioner of Police, Greater Bombay at his office situated on the first floor of Head Police Office, opposite Mahatma Pindle Market, Bombay between 10-00 a.m. to 5-00 p.m. on any working day within thirty days from the date of publication of this Order in the Maharashtra Government Gazette.

#### CONSTITUTION OF INDIA.

No. SAO. 8581/1077(54) TE-2-B.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Maharashtra is hereby pleased to make the following rules regulating recruitment to the post of Director of Vocational Education and Training in the Maharashtra Educational Services (Class D) in the Directorate of Vocational Education and Training of the Government of Maharashtra, namely:—

1. (1) These rules may be called the Director of Vocational Education and Training in the Directorate of Vocational Education and Training (Recruitment) Rules, 1986.

(2) They shall be deemed to have come into force with effect from the 30th March 1981.

2. In these rules, unless the context requires otherwise:

- "Commission" means the Maharashtra Public Service Commission;
- "Degree" means a degree of a Statutory University;
- "Director" means the Director of Vocational Education and Training;
- "Directorate" means the Directorate of Vocational Education and Training, Maharashtra State, Bombay;
- "Government" means the Government of Maharashtra.

3. Appointment to the post of Director shall be made by —
- (a) promotion of a joint Director of Vocational Education and Training-joint Apprenticeship Adviser on basis of selection possessing the qualifications and experience mentioned in clause (b) of this rule; or
- (b) nomination from amongst the candidates who—
- (i) unless already in the service of the Government are not more than 50 years of age;
- (ii) possess a Bachelor's degree in Engineering at least in second class or a Post-Graduate degree in Engineering;
- (iii) possess professional experience, gained after acquiring the qualifications mentioned in sub-clause (ii) in a responsible position for not less than ten years of which not less than five years shall be in the administration of Craftsman Training Scheme or in the Apprenticeship Training Scheme of the Government of India or in a Government Department or in an Industrial Undertaking or in a Commercial establishment or Board constituted by Government or combined professional, teaching and administrative experience in a responsible position in a recognised Engineering College, Polytechnic, Industrial Training Institute, Industrial Undertaking or Government Department;
- (iv) adequate knowledge of Training Schemes and Apprentices Act, 1961.

Provided that

- (a) in the case of candidates possessing the Master's Degree the period spent in acquiring that degree, but not exceeding two years and in the case of those who have completed the Technical Teachers' Training Courses conducted by the Department of Technical Education; shall be counted in computing the period of experience prescribed in clause (iii);
- (b) the age-limit may be relaxed by Government on the recommendation of the Commission in favour of candidates possessing exceptional qualifications or experience or both;
- (c) preference may be given to a candidate who is a member of a Professional Institution or who has research work to his credit.
4. A person appointed to the post by nomination shall be on probation for a period of two years.
5. A person appointed to the post whether by promotion or by nomination shall be required to pass the examinations in Hindi and Marathi according to the rules made in that behalf, unless he has already passed or has been exempted from passing such examinations.
6. A person appointed to the post shall be liable for transfer any where in the State of Maharashtra.

CONSTITUTION OF INDIA.

No. SAO. 8581/1077(54)-TE-2-B.—In exercise of the powers conferred by the proviso to article 309 of Constitution, the Governor of Maharashtra is hereby pleased to make following rules to amend the Director of Vocational Education and Training in the Directorate of Vocational Education and Training (Recruitment) Rules, 1987 namely :—

1. These rules may be called the Director of Vocational Education and Training in the Directorate of Vocational Education and Training (Recruitment) (Amendment) Rules, 1989.
2. In sub-rule (1) of rule 1 of the Director of Vocational Education and Training (Recruitment) Rules, 1987 (hereafter may be called the principal rules) the figures "1987" shall be *substituted* by the figures "1988".
3. In sub-rule (iii) of clause (b) of rule 3 of the principal rules, for the words "or in" appearing between the words "Apprenticeship Training Scheme" and "The Government of India", the word 'of' shall be *inserted*.
