No. SAD 8591/870(835)/VE,3.— In exercise

of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all existing rules, orders or instruments made in this behalf, the Governor of Maharashtra is hereby pleased to make the following rules regulating recruitment to the posts of Joint Director of Vocational Education and Training and Joint Apprenticeship Adviser and Chairman of Board of Maharashtra State Vocational Education examinations in the Maharashtra Education Service, Group 'A' (Senior) in the Directorate of Vocational Education and Training, Maharashtra State under the Higher and Technical Education and Employment Department of the Government of Maharashtra namely:-

1. These rules may be called the Joint Director of Vocational Education and Training and Joint Apprenticeship Adviser/Chairman of Board of Maharashtra State Vocational Education Examinations in the Directorate of Vocational Education and Training (Recruitment) Rules, 1994.
2. In these rules unless the context requires otherwise—

a) "Commission means the Maharashtra Public Service Commission.

b) "degree" means a degree of a statutory University,

c) "Government" means the Government of Maharashtra,

d) "Recognised Institution" means an Institution recognised by Government.

3. Appointment to the post of Joint Director of Vocational Education and Training and Joint Apprenticeship Adviser/Chairman, Board of Maharashtra State Vocational Education Examinations shall be made either :-

a) by promotion of a suitable person on the basis of strict selection from amongst persons holding the post of Deputy Director of Vocational Education and Training and Deputy Apprenticeship Adviser (Senior) in the Maharashtra Educational Service, Group 'A' (Senior); possessing the qualifications prescribed for appointment by nomination in sub-clause (ii) of clause (b) of this rule, OR

b) by nomination from amongst the candidates who,-

(i) unless already in the service of Govt., are not more than 45 years of age;

(ii) possess a degree in Engineering or Technology or its equivalent at least in the second class or a Master's degree in Engineering or Technology or its equivalent; and

(iii) possess professional experience gained

after acquiring the qualifications mentioned in sub-clause (ii) above, in a position of responsibility, or teaching experience in a Technical or Vocational Institution or combined professional, administrative and teaching experience of not less than eight years, including experience not less than four years in the administrative capacity;

Provided that

- (i) In the case of candidates possessing Master's degree, the period spent in acquiring the degree, but not exceeding two years may be counted towards the period of experience prescribed above;
- (ii) the age limit may be relaxed by the Government on the recommendations of the Commission in favour of candidates having exceptional qualifications or experience in one or both;
- (iii) If the candidates with the prescribed period of experience are not available in sufficient numbers those with experience of a shorter period may also be considered.
- (iv) For the post of Joint Director of Vocational Education and Training and the Joint Apprenticeship Adviser, preference will be given to those who have completed apprenticeship training scheme or certificate training scheme and who are corporate.

- members of the professing institutions.
4. Appointment to the post by promotion and nomination shall be in the ratio of 50:50.
5. A person appointed to the post by nomination shall be on probation for a period of two years.
6. A person appointed to the post, whether by promotion or by nomination shall be required to pass the examination in Hindi and Marathi according to the rules made in that behalf, unless he has already passed or has been exempted from passing those examinations.
7. Notwithstanding anything contained in these rules if in the opinion of Government the exigencies of service so require, Government may, after consultation with the Commission, wherever necessary, make appointment to the posts of Joint Director of Vocational Education and Joint Apprenticeship Advisor/Chairman, Board of Maharashtra State, Educational Education and Examinations in relaxation of the percentage prescribed in those rules for recruitment by nomination.
