No. GIW. 1077/30931(70)/TE.2(B).—In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all previous rules, orders or instruments made in this behalf, the Governor of Maharashtra is hereby pleased to make the following rules regulating recruitment to the post of Superintendent, Grade-I, Government Technical High School/Centre, redesignated as Head Master, Government Technical High School/Centre, Engineering Superintendent of Government Technical High School/Centre/Government Technical High School/Centre-cum-Industrial Schools and Principal/Vice-Principal of Industrial Training Institutes in Maharashtra Educational Service Class-II, namely:—

- 1. (1) These rules may be called the Superintendent, Grade-I, Government Technical High School/Centre, redesignated as Head Master, Government Technical High School/Centre, Enginerineg Superintendent of Government Technical High School/Centre/Government Technical High School/Centre-cum-Industrial Schools and Principal/Vice-Principal of Industrial Training Institutes Rules, 1989.
- (2) These rules shall be deemed to have come into force with effect from the 28th day of November 1984.
 - 2. In these Rules, unless the context requires otherwise :--
 - (a) "Commission" means the Maharashtra Public Service Commission!
 - (b) "Degree" means a degree of a Statutory University;
 - (c) "Diploma" means a diploma awarded by the Board of Technical Examinations, Maharashtra State, Bombay or its equivalent.
 - (d) "Government" means the Government of Maharashtra; and
 - (j) "Recognised Institution" means an institution recognised by Government.
- 3. Appointment to the post of Superintendent, Grade-I, Government Technical High School/Centre, redesignated as Head Master, Government Technical High School/Centre, Engineering Superintendent of Government Technical High School/Centre/Government Technical High School/Centre/Government Technical High School/Centre/cum-Industrial School and Principal/Vice-Principal of Industrial Training Institutes in Maharashtra Educational Service, Class-II, shall be made either,—
 - (A) by promotion of a suitable person on the basis of seniority subject to fitness from amongst suitable Class-III persons holding the post of full-time Teachers, Junior Surveyor-cum-Junior Apprenticeship Advisor (Technical), Lecturer in Engineering, Assistant Engineering Superintendent, Assistant Superintendent, Group Instructor in Industrial Training Institute/Basic Training and Related Instruction Centres/Advance Vocational Training Scheme, having completed not less than three years

(c) possess professional experience in a position of responsibility or experience of teaching in any recognised Technical Institute not below the level of Secondary School or combined professional and teaching experience for not less than two years in the case of candidates possessing the academic qualification mentioned in sub-clauses (i) and (ii) above, or not less than six years in the case of candidates possessing the qualification mentioned in sub-clause (iii) above provided that in such cases the six years' period should include two years' experience in Administration of Craftsman Training Scheme/Apprenticeship Training Scheme/Technical High School:

Provided that-

(i) the age limit may be relaxed by Government on the recommendation of the Commission in favour of candidates having exceptional qualifications or experience or both;

(ii) if candidates with the prescribed period of experience are not available in sufficient number those with experience of a shorter period may also be considered.

4. Notwithstanding anything contained in sub-clauses (b)(i), (b)(ii) and (c) of Clause (b) of Rule 3, if at any stage of selection, the Commission of the opinion that sufficient number of candidates possessing the requisite higher basic academic qualifications or experience are not available to fit up the vacancies reserved for candidates belonging to the Scheduled Castes. Scheduled Castes converts to Buddhism, Scheduled Tribes, Denotified Tribes or Nomadic Tribes, then the Commission may, in the matter of such selection relax the requirement in respect of the class in the Degree or Diploma examination or period of experience or both set out therein and select suitable candidates belonging to such casts or tribes.

5. Appointments to the posts by promotion and nomination shall be made in the ratio of 50:50.

6. A person appointed to the post by nomination shall be on probation for a period of two years.

- (3) In the Superintendent, Grade-I, Government Technical High School/Centre, redesignated as Head Master, Government Technical High School/Centre; Engineering Superintendent of Government Technical High School/Centre/Government Technical High School/Centre-cum-Industrial Schools and Principal/Vice-Principal of Industrial Training Institute Rules, 1989 for Clause (A) of Rule 3 the following shall be substituted, namely:—
