No. SRV.1080/2200-KJV-(A) .- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Maharashtra is hereby pleased to make the following rules to amend the Steno-typists, Lower Grade - Stenographers and Higher Grade Stenographers in the Government Offices in Greater Bombay (Recruitment) Rules, 1960, as follows, namely :-

1. These rules may be called the Steno-typists, Lower Grade Stenographers and Higher Grade Stenographers in the Government Offices in Greater Bombay (Recruitment) (Amendment) Rules, 1964.

2. In rule 2 of the Steno-typists, Lower Grade Stenographers and Higher Grade Stenographers in the Government Offices in Greater Bombay (Recruitment) Rules, 1960 (hereinafter referred to as "the principal rules"), clause (a) shall be deleted.

3. In rule 3 of the principal rules, in sub-rule (1), -

- (1) in clause (a), the words "and have completed continuous service of not less than three years in their respective posts" shall be deleted;
- (2) in clause (b), -
  - (i) the words "or by the Board, as the case may be," shall be deleted;
  - (ii) in sub-clause (iii), the words "or by the Board" shall be deleted.

4. In rule 4 of the principal rules, in sub-rule (1), -

- (1) in clause (a), the words "and have completed continuous service of not less than three years in their respective posts" shall be deleted;
- (2) in clause (b), -
  - (i) the words, "or by the Board, as the case may be," shall be deleted;
  - (ii) in sub-clause (iii), the words "or by the Board" shall be deleted.

- 5. In rule 5 of the principal rules, in sub-rule(1) -
  - (1) in clause (a), the words "or have completed continuous service of not less than three years in the post of Lower Grade Stenographer" shall be deleted;
  - (2) in clause (b), -
    - (i) the words "or by the Board, as the case may be," shall be deleted;
    - (ii) the words "or by the Board"

be added, at the end, "Provided that, person appointed in the Commission on the date of his appointment to which he was appointed, shall be the same".
