Subject: Selection of Industry Cluster under scale-up phase of STRIVE project-reg.

Sir/Madam,

As per the reference section 2.2.5 of Operations Manual for STRIVE, approved on 3rd January, 2019 by the Steering Committee Chaired by Secretary, Ministry of Skill Development and Entrepreneurship (MSDE), a National Cluster Evaluation Committee (NCEC) was constituted for selection of Industry Clusters (ICs) under Result Area 4: "Improved and Broadened Apprenticeship Training" under STRIVE project.

2. Under the Project, total of 30 ICs would be selected pan India. State Apprenticeship Advisors were requested to identify potential ICs in their state. Accordingly ICs were identified and mobilized by States and shortlisted through a competitive selection process by State Cluster Evaluation Committee (SCEC) followed by formal recommendation through their respective SSCs. 11 ICs were recommended by NCEC in its meetings held on 1st March, 2019 and 18th October, 2019.

3. For selection of remaining 19 ICs in scale up phase, NCEC meeting was held on 12th February, 2021. NCEC discussed and deliberated the recommendations made by States concerned and agreed to recommend the following 19 ICs:
