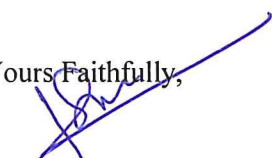

Subject: -Selection of Government ITIs under Phase-2 of Project STRIVE

DGT is opening Phase-2 of Govt ITI selection for STRIVE wherein it has been planned to select 130 plus Government ITIs over and above phase I. Government ITIs will be eligible to apply for selection basis ITI grading score (latest of Phase-1 and Phase-2 ITI grading score) assigned by Ministry of Skill Development and Entrepreneurship (MSDE). All Government ITIs that are meeting eligibility criteria (Govt. ITI with grade of at least 2.0) will be invited to submit ISP online through mobile based Social Cops- Collect App. Access to submit ISP will be provided to such ITIs on their OTP verified mobile numbers. Institute Strategic Plans (ISP) will be invited from sufficient number of graded Govt. ITIs in select states not meeting target in phase I, i.e. 1.3 times the state allocation (Annexure-1).

2. If sufficient number of graded Government ITIs meeting grading criteria of 2.0 and above are not available in the state, then such states will be provided an opportunity to nominate other graded government ITIs to submit ISP under Phase-2 of selection. However, SSC shall ensure that number of such nominated government ITIs in final recommendation list at state level would be subject to a cap of 40% of the state allocation (minimum range).
3. Further after submission through app, the ISPs of Govt. ITIs will be evaluated by respective SPIU of the states and the recommended list will be shared with NPIU(DGT) after due approval of the respective State Steering Committee (SSC). The reason for dropping a higher grade ITI by SSC should be clearly mentioned in the recommendations. NPIU will release the final list of ITI selected on STRIVE DGT Portal after necessary administrative approvals.
4. The selection of ITIs is subject to the fulfillment of the following criteria:
 - a. Selected ITIs must establish an Institute Management Committee (IMC) - if it is not already in place- in accordance with the requirements of the STRIVE project
 - b. Selected ITI to open a dedicated bank account (current account) with Bank of India for all fund flows related to the STRIVE project.
 - c. A tripartite Performance Based Grant Agreement (PBGA) to be signed between MSDE, Respective State Government and the Institute Management Committee for the ITI
5. The tentative activity wise timeline is placed in Annexure-2
6. In view of the above, states/UTs are requested to initiate selection of Government ITIs under Phase-2 of Project STRIVE.
