This pioneering policy initiative aims to reimagine ITIs as world-class skill development and training centre that are agile, future-ready, and closely aligned with the evolving needs of industries and global employment markets and the guidelines envisaging providing directions for the implementation of the PPP Policies across ITIs of the state.

The Directorate of Vocational Education and Training (DVET) under the Skills, Employment, Entrepreneurship and Innovation Department, Government of Maharashtra intends to enter in a partnership with the eligible Partners for the purpose of ITIs upgradation in PPP mode across Maharashtra in line with the PPP policy mentioned above.

Definition

1. **“Department”** means Skills, Employment, Entrepreneurship and Innovation Department, GoM
2. **“Directorate”** means Directorate of Vocational Education and Training (DVET).
3. **“Competent Authority”** means the Skills, Employment, Entrepreneurship and Innovation Department (SEEID), Government of Maharashtra or any of the authority under SEEID or any committee formed by SEEID.
4. **“Contract”** means the Contract signed by the parties along with the entire documentation specified in the EOI.
5. **“Day”** means working day.
6. **“Effective date”** means the date on which the contract comes into force and effect.
7. **“Government”** means State Government of Maharashtra.
8. **“Public Private Partnership”** means an arrangement between a government or statutory entity or government owned entity on one side and a private sector entity on the other, for the provision of public assets and/ or related services for public benefit, through investments being made by and/or management undertaken by the private sector entity for a specified time period, where there is a substantial risk sharing with the private sector and the private sector receives performance linked payments that conform (or are benchmarked) to specified, pre-determined and measurable performance standards.
9. **“Industry Association”** means a formal organization that represents and promotes the interests of a specific industry or MSME clusters or sector or business interest. These associations are formed by businesses and companies operating within the industry to collectively address common challenges, advocate for favourable policies, and promote growth and development of the sector.
10. **“Knowledge Partner”** means a specialized entity or organization that collaborates with businesses, industries, or Partners to provide expertise, knowledge, and insights in specific area. They are typically sought after for their domain expertise, research capabilities, strategic guidance, and advisory services. This may be an academic or business entity.
11. **“Industry 4.0”** is revolutionizing the way companies manufacture, improve, and distribute their products. Manufacturers are integrating new technologies, including Internet of Things (IoT), cloud computing and analytics, and AI and machine learning into their production facilities and throughout their operations. The smart factories are equipped with advanced sensors, embedded software and robotics that collect and analyse data and allow for better decision making.
12. **NGO** means a **non-governmental organization**. An NGO is thought to be a [nonprofit organization](#) that operates partially independent of government control. 13. **Private Company** is defined Section 2 (68) of the Companies Act, 2013 and refers to “a company having a minimum paid-up share capital as may be prescribed, and which by its articles,— (i) restricts the right to transfer its shares; (ii) except in case of One Person Company, limits the number of its members to two hundred: Provided that where two or more persons hold one or more shares in a company jointly, they shall, for the purposes of this clause, be treated as a single member”.
14. **Public Company** is defined in the Section 2(71) of the Companies Act, 2013 and refers to “a company which- (a) Is not a private company; (b) Has a minimum Paid-Up Share Capital of Five Lakh Rupees or such higher paid-up capital, as may be prescribed: Provided that a company which is a subsidiary of a company, not being a private company, shall be deemed to be public company for the purposes of this Act even where subsidiary company continues to be private company in its Articles”.
15. **Skill Universities** are primarily regulated by the University Grants Commission (UGC) under the UGC Act and Regulations. They are designed to focus on **vocational education and training (VETS)**, emphasizing practical skills and industry readiness.

16. **“Personnel / Resources / Manpower”** means professional and support staff provided by the PPP Partner and assigned to perform services to execute an assignment and any part thereof.
17. **“Services”** means the work to be performed by the Partners pursuant to the selection by Directorate of Vocational Education and Training (DVET) under Skills, Employment, Entrepreneurship and Innovation Department, GoM and to the contract to be signed by the parties in pursuance of any specific assignment awarded to them by Directorate of Vocational Education and Training (DVET), GoM.

2. Project Details

2.1. Introduction:

The Directorate of Vocational Education and Training (DVET), Government of Maharashtra, invites Expressions of Interest (EOI) from reputed and eligible Partners (from Public companies or Private companies or Industry Associations or NGOs or Skill Universities) for establishing long-term, strategic public-private partnerships (PPP) with selected Government Industrial Training Institutes (ITIs) across the state of Maharashtra. This initiative is part of the transformational reforms outlined in the Government Resolution dated 02nd June, 2025, aimed at upgrading ITIs through industry-led skilling, infrastructure modernization, apprenticeship promotion, and employment-oriented curriculum design.

The primary objective of the ITI upgradation should include the following but not limited to:

- The infrastructure, such as - ITI building, Classrooms, labs, hostels and associated Machineries & tools for the approved courses.
- The courses/ curriculum, to commensurate with the Industry demands and latest technological advancement specially towards the innovative trades / courses not limited to the area of drone technology, electric vehicle, industrial robotics and any other futuristic industry requirements.
- The trainers, towards enabling them through the appropriate “Training of the Trainer (ToT)” mode. This can include the qualified / eligible Trainers to get introduced to the industrial ecosystem for better understanding and capacity building.
- Partners may collaborate with other Partners / NGOs for any relevant short term or long term training to be incorporated in the curriculum.
- It shall not preclude other Partner from partnering in other Short terms and Long term courses subject to concurrence of the IMC
- Operate courses and provide equipment, infrastructure, construction, faculty hiring, and training.
- Develop and deliver joint certification programs with competent agencies (e.g., National Council for Education and Vocational Training, Maharashtra Board of Skills, Vocational Education and Training, Ratan Tata Maharashtra State Skill University).
- Offer courses to enrolled ITI trainees and external candidates, with training fees (paid by candidates or reimbursed under schemes) generating revenue for the Institute Management Committee (IMC).
- Ensure industry-backed certifications to enhance employability and global job opportunities.
- Upgradation of existing hostels in case required and included in the respective ITI

Under this EOI, DVET seeks to:

- Empanel interested Partners in co-developing and co-managing ITIs under a structured PPP model.
- Facilitate convergence of industrial expertise and public infrastructure to enhance the quality of vocational education and training.
- Expand industry participation in curriculum planning, trade diversification, equipment support, and placement efforts.

Interested Partners may express their willingness to partner with one or more ITIs listed in the Annexures of the PPP Policy (Annexure-1, Annexure-2, or Annexure-3) and must commit to the financial, technical, and strategic support as outlined in the policy guidelines.

Participation in the selection process is valid only upon successful submission of the complete application, along with all supporting documents, within the prescribed deadline, and via the specified online submission mode. The Directorate reserves the right to modify, postpone, or cancel the EOI process at any stage without assigning any reason.

2.2. Objectives:

- Strengthening the linkage between the skilling and industrial ecosystems to create workforce for new age job roles with assured overseas placement opportunities.
- Develop a conducive environment that fosters innovation by supporting entrepreneurs in prototyping, product development, business development, talent acquisition.
- Establishing partnerships with international employers to facilitate placement of candidates in overseas job market.
- Providing a platform for students across ITIs, polytechnics and engineering colleges to develop industry specific skill sets and industries to upskill their working professionals.
- Create skill first day first hour job ready workforce before their induction in industries.

2.3. Broad Scope of Work:

The primary objective and transformation of the ITI should include the following:

- I. The infrastructure, such as - ITI building, Classrooms, labs, hostels and associated Machineries & tools for the approved courses.
- II. The courses/ curriculum, to commensurate with the Industry demands and latest technological advancement specially towards the innovative trades / courses not limited to the area of drone technology, electric vehicle, industrial robotics and any other futuristic industry requirements.
- III. The trainers, towards enabling them through the appropriate “Training of the Trainer (ToT)”
- IV. mode. This can include the qualified / eligible Trainers to get introduced to the industrial
- V. ecosystem for better understanding and capacity building.
- VI. Lead Partners may collaborate with other Partners for any relevant short term or long term training to be incorporated in the curriculum.
- VII. Operate courses and provide equipment, infrastructure, construction, faculty hiring, and training.
- VIII. Develop and deliver joint certification programs with competent agencies (e.g., National Council for Education and Vocational Training, Maharashtra Board of Skills, Vocational Education and Training, Ratan Tata Maharashtra State Skill University).
- IX. Ensure industry-backed certifications to enhance employability and global job opportunities.
- X. Upgradation of existing hostels in case required and included in the respective ITI

2.4. Minimum Investment requirements:

Minimum investment from the selected PPP partner is envisaged as:

- ₹10 crore for 10-year partnership
- ₹20 crore for 20-year partnership

PPP Partners are expected to contribute to both capital expenditure (CAPEX) and operational expenditure (OPEX) through:

- Direct Investments in setting up of ITI infrastructure: Industries will invest in equipment, infrastructure, construction, faculty hiring and training, etc. in addition to funds available under regular budgetary provisions.
- Minimum 60% of the total contribution from industrial partners should be in form of Capex and rests 40% in form of Opex.

The operating expenditure includes costs related to faculty remuneration by the selected partners, procurement of materials and equipment for new labs, infrastructure setup and maintenance, expert salaries,

staff training, and organizing academic events. However, it excludes expenses like salaries of existing staffs and reimbursements under existing government schemes or scholarships.

PPP Partner's contribution both in terms of capex and opex shall be considered on basis of market price or purchase price whichever is less. Funds available under budgetary provisions and schemes shall continue in a regular manner to the Institute. Where ever necessary in the state and especially for the Government ITIs mentioned in **Annexure 3 of the Policy dated 02nd June, 2025**, the option of selecting partners may be done on the basis of industry solicitation or expressing their interest through Viability Gap Funding (VGF), on the basis of highest investment and least VGF (**which can be 30% of total investment proposed or 10 Cr. whichever is lower**) quoted by the Partner.

Funding through the Viability gap funding (VGF)

Viability Gap Funding in form of the financial support mechanism may be provided by the Government to make infrastructure projects financially viable when they are economically justified but not financially attractive to private investors. It typically covers a portion of the capital cost.

The VGF option primarily be applicable for the Annexure – 3 listed ITIs of the PPP Policy dated 02nd June, 2025, the selection of the PPP Partner shall be done on the basis of highest investment and least VGF (which can be 30% of total investment proposed or 10 Cr. whichever is lower) quoted by the Partner. For other ITIs, the State Steering Committee will take a view on VGF requirements on the basis of industry requirements and submitted DPR justifying the VGF.

Funding Mechanism:

- VGF (As described in this guideline)
- The remaining cost will be raised by the interested partner.
- Funds will be disbursed in a phased manner based on project milestones.

2.6. Benefits to the Partners

2.6.1. Dedicated Space (up to 2,000 sq. ft.):

- For product display and skill demonstration to familiarize students with advanced technologies and promote skill-based entrepreneurship.
- Space may be used for publicity (e.g., hoardings, banners) to promote skill courses.

2.6.2. Leveraging existing Infrastructure and Resource Pool

The PPP Partners can leverage the ITI ecosystem of Government of Maharashtra by bringing additional investments through this PPP policy, where the DVET, GoM will be bearing the operational cost of approximately 60%-70% in form of salaries of existing resources, notional rents of the existing infrastructure, machineries and equipment.

The existing ITI ecosystem brings the following benefits -

- Existing ITI infrastructures (ITI Buildings, Workshops, machineries and other facilities) carry high rental value which is available to the selected Partner to leverage under this PPP Policy.
- Use of ITI as an extended facility for inhouse trainings, seminars
- Availability to captive trainees of the ITI
- Availability of space to run self-funded courses
- Premium location with trained faculty and support
- Salary of existing government employees

2.6.3. Industrial and Technological Exhibitions:

- Partners can organize public awareness exhibitions on ITI premises.

2.6.4. Service Centres:

- Industry expert- and student-managed service centers (e.g., for automobile industries) for on-the-job training and real-world exposure, benefiting both students and the community.

2.6.5. 2 Skilling Centres:

- PPP Partners may establish two dedicated skill centers at the respective ITIs, supported by the Maharashtra State Skill Development Society (MSSDS). These centers will offer advanced, industry-relevant courses aligned with high-demand sectors, and will be integrated with placement facilitation services to ensure effective linkage with employment opportunities.

2.6.6. Additional Batches:

- Partners may run fee-based evening training batches (5:00 PM–11:00 PM) to address demand (4.5 lakh applicants for 1.25 lakh seats annually).

2.6.7. Skill University Affiliation:

- Option to offer Skill University courses via affiliation, providing students with higher education pathways.

2.6.8. Office Space:

- Office space of not more than 10,000 sq ft (built up) may be provided to the respective partner, only for the purpose of smooth operations. The permanent employees who are required for operations may be allowed to reside in this building which shall be constructed at the sole risk and cost of respective partner with the approval of Authority.

2.6.9. Administrative Incentives:

- Adopting PPP Partners can introduce new trades in ITI's for which Government will extend help for Green Channel approval
- Dual System of Training (DST) will be implemented by the partner in the ITI for the students
- The Industry investment can be either from their own or other industries CSR fund
- There shall be an exit policy provision for the adopting PPP Partner after (3-5) years.

Partners is expected to submit their responses after conducting the field visits of the ITI and post assessment of the actual premises .

- If any proposal/ interest received against the similar ITI(s) or cluster of ITIs from more than one partners, in such scenario presentation may be called by the authority from the Partners.
- Presentation shall be evaluated on the basis of approach & methodology of the upgradation plan of the ITI along with the placement commitments for the same and proposed industry linkages on the geographies.
- Based on the EOI responses received, the authority reserves the right to call the Partners for the **Presentation** on the above parameters and may ask to submit the documentary evidence where required. Final decision shall be taken by DVET with approval from the SEEID, Government. DVET reserves the right to accept/reject any offer, without assigning any reason whatsoever.

4. Instructions to the Partners:

4.1. Completeness of Response:

- 4.1.1.** Partners are advised to study all instructions, terms, requirements, and other information in the EOI documents carefully. Submission of the response shall be deemed to have been done after careful study and examination of the EOI document.
- 4.1.2.** The response to this EOI should be full and complete in all respects. The proposals to the EOI documents in every respect will be at the Partners' risk and may result in rejection of its Proposal.

4.2. EOI Proposal Preparation Costs and related issues:

4.4. Submission of Proposal:

4.5. Points to be kept in mind for submission of proposal:

- 4.5.1.** EOI document submitted by the Partners should be concise and contain only relevant information as required under this EOI.
- 4.5.2.** The Directorate shall not accept delivery of proposal in any manner other than that specified in this EOI. Proposal delivered in any other manner shall be treated as defective, invalid, and rejected.

4.8 Implementation Process:

- 4.8.1.** A task force shall be created at the appropriate level / levels to oversee the smooth implementation of the project with representatives from the Partners, Partners and SEED.

4.9 Confidentiality:

4.10 Force Majeure:

No failure or delay or omission by either party to fulfill any of its obligations under the terms of the EOI shall give rise to any claim against such party or be declared to be a breach of any terms and conditions defined in the terms of EOI if any to the extent such failure, delay or omission arises from the 'Force Majeure' event not within the reasonable control and at the instance of such party (each an event of 'Force Majeure'). Events of force majeure shall be:

4.11 Mediation:

- 4.11.1.** In the event of any dispute, controversy, or claim arising out of or relating to this contract, the parties agree to first attempt to resolve the issue through mediation as part of pre-litigation measures. Mediation shall be conducted in accordance with the provisions of the Mediation Act, 2023.
- 4.11.2.** The mediation proceedings shall be initiated by either party by serving written notice to the other party specifying the nature of the dispute. Within 30 days of receiving the notice, both parties shall appoint a mutually agreed-upon mediator or, in the absence of mutual agreement, the mediator shall be appointed by the Secretary, Skills, Employment, Entrepreneurship and Innovation Department, GoM.
- 4.11.3.** The mediation shall be conducted in Mumbai, Maharashtra and shall be completed within 120 days from the date of appointment of the mediator. The mediator shall facilitate discussions between the parties with the aim of reaching an amicable resolution to the dispute. If the parties are unable to reach a resolution through mediation within the stipulated time frame, either party may then pursue further legal action, as permissible
