Applicants may be informed "No partial affiliation shall be granted".
- ii. **New age Courses:** Existing ITIs willing to start New age courses may be encouraged with at least 4 trades having combination of minimum 1 Engineering, 1 Non-Engineering and 1 New Age Course.
- iii. **Existing ITI having less than 4 Trades:** To maintain trades diversity, all existing ITIs having less than 4 trades, may apply for seeking Affiliation in additional trades/ units conforming to norms for at least 4 trades having combination of minimum 1 Engineering, 1 Non-Engineering and 1 New Age Course, based on which NOC may be issued as per the trades' demand.
- 2. Applicant seeking affiliation in any of the above category shall apply for NOC from the concerned State/UT Director and thereafter, shall apply on online affiliation portal https://www.nimionlineadmission.in/iti. The portal will open for one month from 19th July to 18th Aug.2021.
