- 3. The quotations must be supported by necessary technical literature, and other documents as mentioned in this document.
- The bidder must not be a defaulter to any Government authorities and must not have been black listed/debarred from supplying goods.
- The bid must be for all inclusive price of the goods/services and must include all taxes and levies, transpiration charges, freight etc. Delivery to the consignee has to be effected within 1-2 weeks from the date of issue of purchase order.
